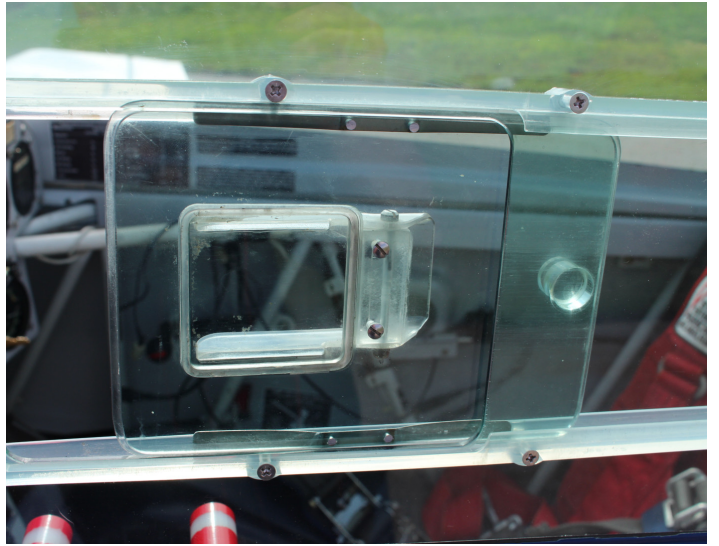

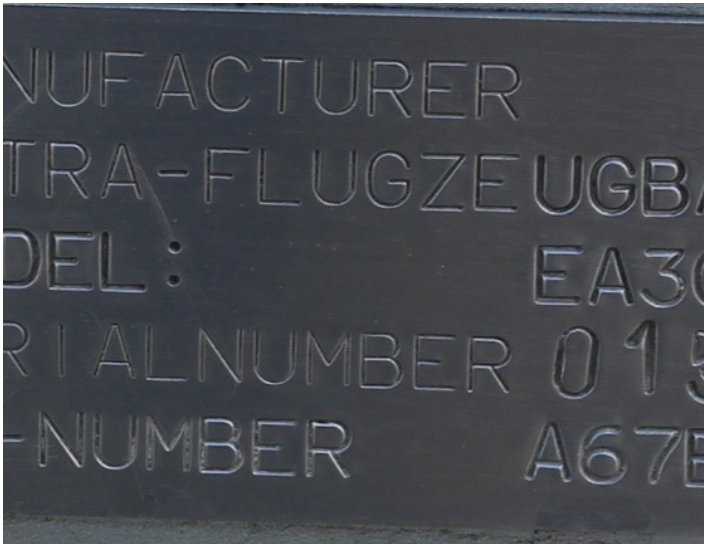
5. AUTHORITY AND BASIS FOR ISSUANCE
